FOR GOOD AND VALUABLE CONSIDERATION, it is mutually agreed as follows:

- 1. The designated product(s) of Exhibitor is (are) solid waste systems, equipment, or related items or services.
- 3. Exhibitor shall pay for the Space and Committee shall accept the total sum payable as follows: Payment is due within 30 days of receipt of the executed agreement to guarantee reserved space. The total sum payable shall be determined by the space size and space number, identified on the official Show diagram, and priced as follows:
 - \$1,350 each All Spaces Nos. 1 36: 10' x 10'
- 4. For the total sum payable, as identified in paragraph 3, above, the Committee will provide the Exhibitor with the space number identified in paragraph 2 of the executed agreement. All booths include a six foot skirted table and two chairs. Each booth and table assignment will include one FULL SYMPOSIUM REGISTRATION and two EXHIBITOR badges, which will admit the badge holders into the exhibit area and technical sessions only for the duration of the symposium.

- 5. If Exhibitor does not exhibit the designated product(s) in the Space or otherwise fails to comply with any of the terms of this Agreement, the Committee shall have the right, without notice to Exhibitor, to sell or offer the Space for sale at public or private sale and Exhibitor shall pay to Committee any deficiency, loss or damage suffered by Committee by reason thereof, including the reasonable expenses and costs incurred. Occupancy of the Space is of the essence of this Agreement and should Committee be unable to effect a sale of the Space as herein provided, it shall have the right to occupy or cause the Space to be occupied in such manner as it may deem in the best interest of the Show or cause Exhibitor's name to be placed on the board over the Space, all without releasing Exhibitor from any liability there under.
- 6. Exhibitor shall not assign or sublet any part of the Space without the written consent of Committee. All exhibits shall be subject to the approval of Committee. Only the name of Exhibitor may be used over or in the Space or may be included in the printed list of exhibitors and program of the Show.
- 7. In case the Space shall not be available for the uses herein specified due to causes beyond the control of Committee, this Agreement shall immediately terminate and in such event Exhibitor shall and does hereby waive any claim to damages or any other recovery therefore except the return of the amounts paid as rental for the Space, less the pro-rata share which can be allocated to the Space for the actual expenses incurred by Committee in connection with the Show. Should Committee, in its sole discretion, consider it inadvisable to hold the show at the time and place herein provided, Committee may at its option terminate the Agreement, return the sums paid by Exhibitor for the Space and there shall be no further liability on the part of either party to the other. Upon written notice to Exhibitor, Committee shall also have the right to change the date and the place where the Show is to be held.
- 8. Committee will not be responsible for any injury that may arise to Exhibitor, its employees or others, or for the loss or damage to any material from any cause whatsoever while in transit to or from the building or while in the show whether or not Committee furnishes attendants, guards or watchmen. Exhibitor agrees to hold Committee harmless from any suits, liability or claim from damage or injury, sustained by any person, arising out of Exhibitor's use of the Space and its activities in connection with the Show.

- 9. The Rules and Regulations provided by the Embassy Suites Monterey Bay Seaside, hereby are made a part hereof as though fully incorporated herein and Exhibitors shall be bound thereby. Committee shall have the right to interpret, amend and enforce said Rules and Regulations. This Agreement may not otherwise be amended except in writing signed by both parties. This Agreement constitutes the entire agreement between the parties.
- 10. This Agreement is made in and shall be constructed in accordance with the laws of State of California.
